#### **Shizuoka Prefecture**

The deadline for payment is June 2<sup>nd</sup>.

#### Tax Rates

The tax rate is calculated according to the type of vehicle (passenger vehicle, truck etc.), engine displacement, and the maximum loading capacity. However, the tax rate may change depending on the vehicle's emissions and fuel consumption.

#### ■ Tax Payment Certificate

If you have a vehicle inspection scheduled within three weeks after tax payment, you might need to show the tax payment certificate during inspection. In that case, please make payment at a bank, post office, convenience store or MMK terminals in order to receive the tax payment certificate.

# Automobile Tax Reduction or Exemption (The following may be eligible for tax reduction or exemption.)

- · Vehicles use exclusively for and by persons with mental or physical disabilities.
- Vehicles damaged by natural disasters or other disasters caused by unforeseen circumstances. For more information, please check at your local tax office.

### ■ Vehicle registration process

Please register and update your vehicle registration information at the Transport Branch Office if you:

- ① Sell or transfer ownership of your vehicle or scrap your vehicle.
- ② Change your address

\*If you do not update your information, it may cause problems such as receiving tax payment notices for the previously-owned vehicle.
